



# BART to Livermore Extension Project

## Notice of Availability for the Draft Environmental Impact Report (DEIR) & Public Review

The San Francisco Bay Area Rapid Transit District (BART) has issued a Draft Environmental Impact Report (DEIR) for the proposed BART to Livermore Extension Project, which would extend transit service into Livermore. BART is currently accepting public comments on the Draft EIR.

### PROPOSED PROJECT

The Proposed Project, which is being developed in partnership with the City of Livermore, consists of a 5.5 mile BART extension along I-580 to a station near the Isabel Avenue/I-580 interchange. The Proposed Project also includes new and modified bus services linking Altamont Corridor Express (ACE) stations and activity centers in Livermore such as downtown Livermore, Las Positas College, and Lawrence Livermore National Laboratory (LLNL).

The Draft EIR evaluates several alternatives to the Proposed Project, including a No Project alternative, a Diesel Multiple Unit (DMU) alternative, an Express Bus/Bus Rapid Transit alternative, and an Enhanced Bus alternative. The Proposed Project as well as the DMU alternative include storage and maintenance facilities for effective operations.
